LETTER FROM THE CHAIR & PRESIDENT

Public opinion is a powerful tool. That is why Research! America has, for the second year in a row, created this poll data booklet. It provides you with the most up-to-date information regarding public opinion on medical, health and scientific research matters, and makes suggestions on how to use poll data with impact.

During the past 10 years, Research! America has been conducting public opinion polls to monitor the pulse of the nation on medical and health research issues. Since our first poll in Maryland in 1992, Research! America has commissioned both national polls and thirty-three separate state polls.

Consistently, our polls demonstrate that citizens want the United States to retain its role as the world leader in medical, health and scientific research. The public has also weighed in on the importance of state leadership and on its willingness to pay more for the conduct of that research. Although the public feels certain that more should be done to increase our national investment in this important research, people are not as informed as they could be about the debates surrounding research. The citizenry, in fact, does not feel as connected as they would like to be to researchers and to the academic institutions, government agencies and business enterprises which conduct that research.

Public sentiment on medical, health and scientific research is clearly favorable – overwhelmingly so. But, that sentiment is a story that is not told often enough. As your partners in public education and advocacy, we're happy to help you spread the word.





State Leadership In Science & Technology Research Is Important


How important is it for your state to be a leader in science and technology research?

1996: Support For Doubling


Currently, about 3 cents of each health care dollar spent in the U. S. goes for medical research. How many cents out of each health care dollar do you think we should spend on medical research?

2000: Support For Doubling


Do you support or oppose a proposal to double total national spending on government-sponsored medical research over five years?


National Priorities

Eliminating Health Disparities Is Important








Uses For Tobacco Settlement Money

If your state offered financial incentives to attract new medical research, such as labs, would you approve or disapprove of these incentives?



Science & Engineering Research Is Important To State's Economy


In terms of jobs and incomes, how important do you think spending money on scientific and engineering research is to your state's economy?

Support Of University Science & Engineering Research Is Important


How important do you think it is that your state keep supporting science and engineering research that is carried on in your state's universities?

Would you favor or oppose spending part of the federal budget surplus on medical research?




Public Is Willing To Pay More For Prescription Drugs

1996: Public Is Willing To Pay More In Taxes


Would you be willing to pay \$1 per week more in taxes for more health research?

2000: Public Is Willing To Pay More In Taxes


Would you be willing to pay \$1 per week more in taxes for more health research?



Congress Should Support Tax Incentives Encouraging Medical Research


Congress should support tax and regulatory policies that encourage private industries to conduct more medical research.


Is the following a reason why we are not making more progress in medical research?

Even if it brings no immediate benefits, basic science research which advances the frontiers of knowledge is necessary and should be supported by the Federal Government.





Most Do Not Recognize The National Institutes of Health (NIH)


What is the name of the government agency that funds most of the medical research paid for by taxpayers in this country?


Many Recognize The Food and Drug Administration (FDA)



What is the name of the government agency that funds most of the basic research and educational programming in the sciences, mathematics and engineering in this country?




Public Doesn't Know Where Research Is Conducted

Doctors Are Preferred Source For Health/ Medical Research Information


If you needed to learn more about a particular health or medical research issue, how would you choose to get this information?

Health Services Research Is Of Value


One kind of research, called health services research, seeks to understand why there are differences in quality of care and outcomes for patients. How do you perceive the value of this kind of research?

How compelling do you find each statement for supporting an increase in funding for health promotion and disease prevention research?



Of the people or organizations listed below, which three do you think are in the best position to increase awareness and support for health promotion and disease prevention research *in Congress*?





How important do you think it is that the health promotion and disease prevention community be active participants in each of the following?



How persuasive would you find each of the following reasons for increasing support for health promotion and disease prevention?




Why is this information so important?

- Because 72 percent of the public says that the media do not give enough attention to medical research.
- Because 86 percent of the public feels it is very important that the U.S. maintains its leadership in scientific research.
- Because 96 percent of the public feels it is important for their respective state to be a leader in medical research.
- Because medical and health issues (such as long term care) are rising on the public's agenda.
- Because many research issues are debated on a daily basis, such as: research funding, patient safety, stem-cell research, cloning and freedom of information and privacy.



How likely would you be to participate in a clinical research study?



How much of a concern would the following factors be in your decision to participate as a volunteer in a clinical research study?


(Percent saying major concern)



What concerns, if any, do you have about scientific research?



Can you think of any area of medical research where the government is spending too much money?


