Dear Speaker Pelosi, Leader Schumer, Leader McConnell, and Leader McCarthy:

On behalf of Research! America, a nonprofit, nonpartisan alliance advocating for faster medical and public health progress, thank you for the hard work you and your respective staff members are devoting to ensuring we as a nation are successfully responding to the COVID-19 pandemic. Bipartisan efforts in Congress have contributed in profoundly important ways to public and private sector research and development, catalyzing our understanding of the disease and the development of diagnostics, vaccines, and treatments. As the pandemic continues, we urge you to move expeditiously to secure passage of the pending \$10 billion COVID-19 funding package.

We perceive this funding as an essential piece of the puzzle as our nation continues to fight COVID-19 and carves a path to global pandemic security over the long-term. A recent survey commissioned by Research! America found that 71% of respondents agree that the COVID-19 pandemic is a disruptive event and requires that the U.S. assign a higher priority to science & technology. Increased focus and funding for research and development (R&D) will generate progress that is additive to the hard-earned knowledge already uncovered by public and private sector-funded scientists as they have fought COVID-19 and other global infectious threats. As that knowledge base grows, so does the ability of the R&D and public health ecosystems to out-innovate potential pandemics wherever and whenever they arise.

The R&D you empower now, and the additional work that must be done to understand and prepare for other viral threats, are not simply investments in medical and public health progress; they are investments in life expectancy, job security, economic stability, and U.S influence in the global sphere.
